

Section 3 – External Auditor Report and Certificate 2019/20

In respect of **SU0014 – Capel Parish Council**

1 Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2020; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2019/20

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review:

- The smaller authority has not addressed the 'except for' matters raised by the external auditor when qualifying the prior year annual return. The prior year Section 2, Box 10 should have been restated to £101,141.94 in order to be consistent with the balance published by the Public Works Loan Board.

The smaller authority has disclosed that it made proper provision during the year 2019/20 for the exercise of public rights, by answering 'Yes' to Section 1, Assertion 4. However, as was reported last year, we are aware that it failed to do this and therefore should have answered 'No' to this assertion. It has also disclosed that it took appropriate action on all matters raised in reports from internal and external audit, by answering 'Yes' to Section 1, Assertion 7, which, on the basis of the above, is not correct.

Other matters not affecting our opinion which we draw to the attention of the authority:

The date of approval of the AGAR noted on Sections 1 and 2 is 16/06/20 however the Minutes indicate that the meeting was held on 15/06/20. Please note that the date of approval should be included on both Sections 1 and 2. Furthermore the Minutes do not actually state that the AGAR was approved although this is implied in the Minute reference referred to on the face of the AGAR. The smaller authority should ensure that the resolutions in the Minutes are clearer and that when approving the AGAR that they state that Section 1 and Section 2 were approved. Please note that Section 1 should be approved before Section 2 and this should be clear in the Minutes.
