4. MATTERS ARISING: (i) Ref:6-01/2/12- An application has been made to Cllr.Clack for funding from the Dorking Rural Diamond Jubilee Celebration funds for £630 towards the planting of the five Elm Trees in the Parish. (ii)'Police Off Road Bikes' - PC Mark Trezise had given positive reports of use of the bikes with over 100 'conversations' having taken place.

7.TO NOTE INTERNALAUDIT APRIL 2012

8. INSURANCE POLICY SCHEDULE 2012/13

1) It was confirmed that under Part 0 – Personal Accident -the cover is limited to £500,000 for any one person and £2M any one incident and that the persons insured are Employees, Volunteers and Councillors.

2) Use of MUGA is covered under the Zurich Public Liability policy. (It has not been possible to get confirmation of insurance cover for the surface under the SCC scheme)

9. FURTHER BUDGET CONSIDERATIONS FOR 2012/13

There could be no further consideration given to PC funding for LHAG's costs for the Europa Oil Appeal until the PC's own costs are known.
An allocation should be made in the 2012 / 13 budget for re surfacing the lay-by area in front of the Capel Meeting House. (maintenance of the area falls to the PC)
