This being Cllr Pearson's last meeting of the full Council as Cllr for Capel ward, the Chairman took the opportunity to thank Mrs Pearson profusely for the contribution she had made over many years to the Parish and particularly to Capel ward where she had helped and advised on a broad range of matters. It was agreed that a subcommittee of Mr Ball, Mrs Schryver, Mr McLachlan, Mr Salter and the Clerk be set up to consider the needs of the Council in terms of the software on offer, its appropriateness for the Council and the comparative costs for the Pear mapping software and the hosting route via Microshade VSM.

(iii) Clerk reminded to approach Crest re the posts they agreed to install at the northern entrance to Beare Green (LHS approaching Beare Green) as part of the Godwins agreement. Also to request from Highways for the reinstatement the PC's grass verge in OHRd outside the entrance to Chorus Gardens

Capel: (i) Parish Hall – visit to Horley Hall on 12th May to see similar Hall to that required at Capel. Put forward plans for Parish Hall to meeting of Village Hall Committee 27.04.15 for circulation to the Capel community. Have to show agreement of the community to the Public Loans Board (ii) <u>Bonfire Field:</u> Mr Denney one of joint owners, had been sent a written communication to the effect that CPC would not under any circumstances permit an easement for UK Power Networks to install electricity in the field. Subsequently the land has been put up for sale. *Coldharbour:* (i) The Clerk to write to SCC Local Committee in support of Cllr Watson's scheme to extend the 40MPH (ii) A collision between a cyclist and pedestrian outside the Plough Inn had resulted in serious injury to the pedestrian. Highways to be approached about putting in traffic calming measures to slow traffic / cyclists along this stretch of road. The possibility of a cattle grid to be considered. (Cllr Mir)(iii) GLEAM delighted with evidence provided – only evidence submitted from the south

1 <u>Re surface Misbrooks Green Bridleway</u> Fred Evans is quoting £3,850. The five Misbrooks Green households are undertaking the work but have requested that the PC make a contribution. Councillors agreed a grant of 15% ie £577
