045d UPDATE ON EUROPA OIL PLATFORM APPEAL

(I) Pre Inquiry meeting will take place at 2.00pm on Thursday 3rd May at County Hall. The meeting is open to the public.

(ii) It was agreed that Mr David Boswell, a leading Highways consultant known to the Planning Inspectorate, be asked to comment on the Highways Issues associated with Coldharbour Lane and relevant to the Appeal.

046A FINANCE

(i) Grant request for:

Europa Oil Appeal: LHAG has already raised a considerable amount from private donations and undertaking fund raising events but a shortfall in funding is expected. The PC will have its own level of expenditure to consider for key witnesses if there is a strong case to argue re Coldharbour Lane. MVDC, Cllr Clack, The Roundtree Foundation should also be approached for funding. Cllrs. agreed a £2,000 allocation from reserves to cover the PC's costs with any remaining funds going towards LHAG costs.

<u>Capel Youth Club:</u> Comparative data relating to 2008/9, 2009/10 and 2010/11 had been submitted and it was agreed that the £250 grant plus hire of minibus to the value of £99.00 should now be paid. (copy on file)

(ii) Accounts and Audit regulations for Internal Control and the Management of Risk.

1) The above Briefing note from BDO (External Auditors) had been circulated to all Councillors. The items listed were addressed in order.

2) The Council continues to undertake a six monthly internal audit (April and October). An audit plan is in operation.

3) Review of Internal Audit- The internal Auditor is appointed annually at the Annual Meeting, the IA is independent of the Council's financial controls and procedures, the IA reports to the Council after each audit by means of a written report, the IA is professionally qualified although he is not required to be. The IA assists in the end of year process.

3) An annual Risk Assessment was conducted in September. A copy of the check list and outcomes was presented to Councillors.

4) Budget Monitoring of spend against budget allocation is undertaken quarterly at the Finance Committee meetings and reported back to the Full Council for approval.

3) Details of insurance cover were given. Insurance cover is reviewed annually and when new equipment is purchased. The Clerk to establish from SCC the current situation re the MUGA insurance which was to be financed out of grant funds for 5 yrs.

3) Copies of the Council's Register of Assets were circulated; the Register is updated annually and if necessary during the year. One strip of land is to be added for Coldharbour to represent the small plot of Common Land owned by the Council.

4. The Council's Control systems are monitored as part of risk assessment and internal audit as above.

046B HIGHWAYS MATTERS

Cable laying in The Street, Capel

1)Date of completion remains end of March.

2)Reinstatement of all affected verges will take place once all the works are complete.

3)A request has also been made for the 'jetter' lorry to jet through the gullies along The Street, Rusper Road, Vicarage Lane and Temple Lane.

Flooding in Temple Lane

1)Agreement has been reached regarding the clearance of the first section of blocked field ditch.

2)The PC will have debris removed from either side of the two road bridges 3)Highways have agreed that the sides of the ditches will be built up with bagged concrete.

4)The PC will replace the broken drain under the field entrance at this point – to take flood water from the ditch, under the entrance and into the brook. Richard Brown (The Garden) is quoting $\pounds 3,195$ (ex VAT) to:

Install a new pipe as above, to clear ditches and dig gullies at suitable points and remove spoil from site, plus lay concrete footings for brickwork pipe surrounds. Councillors agreed to accept the quote.

5) Highways propose to build up the side of the bridge with concrete sacks and will jet through blocked drains in this area to try and get rid of surface water and enable some of the potholes to be filled.

046F WARD MATTERS

Capel: (i) Parking at Ockley Station: Any action at Ockley station to increase parking space would have a positive knock on effect in reducing 'on street' parking in Coles Lane and Old Horsham Road, Beare Green. The Clerk to reply to Ockley Chairman re parking at Ockley station to effect that preference would be for Mr Marshall to lay out his goods yard for parking with an agreement that it could revert back if PP were given for development. If a $\pounds 1,000$ split charge was involved Capel would look for some form of self funding. If the triangle of Mr Lee Steer's land were used for parking spaces it should be screened by trees from the neighbours and shared costs over a number of years would be preferable to a permanent annual fee. Permit Holding might be used. If herring bone style parking were used for the existing parking spaces better use would be made of the space.

Mr McLachlan to be informed when discussions planned with Mr Marshall.

(ii) FP 190 / 197 off Vicarage Lane, Capel – problems with the path becoming almost impassable had been reported to Claire Sauders, Countryside Access Officer who had already taken positive action.

046D PARISH MAINTENANCE

1) Bridlepath 214 – Misbrooks Green

(i)Bill Kear contractors have agreed to re scarify and roll several sections of the path that have shown unusual deterioration since resurfacing in June '11.(ii)The two posts to mark the entrance of the path have now been installed

2) The PC will be working with the Horticultural Society clearing litter in Capel on Saturday April 14th.

The Clerk to write to MVDC asking that:

(i) Something be done about the vast amounts of litter on the highway verges in Mole Valley and that when contractors are employed on roadworks in the district eg Landbuild in Rusper Road that they are under contract to leave the site clear of litter.

(ii) That greater care should be taken not distribute / re distribute re cyclables on the pavements / in the roads on bin emptying days.
