# 046C PARISH AND HIGHWAYS MAINTENANCE Parish Maintenance

<u>The gully at the end of Moorhurst Lane.</u> Part of the pavement has collapsed into the gully & needs clearing + debris to be removed from site. Most of the damage is on PC verge and edge of the PC pond. Sides of gully to be built up with sand bags (concrete) The ditch against the southern carriageway which the gully feeds into will need investigating. Clay Griffin & Fred Evans with digger have undertaken the emergency work, with, hopefully, Highways tarmacking over.

## **Highways Matters**

1) Flooding ditch in Vicarage Lane.- Highways have verbally agreed that now the neighbours do not object to an obstructing Oak being felled they will progress with draining the ditch. Freezing of the ditch, road and pavement at this point resulted in as recent car accident subsequently reported to Highways 2) Project Horizon has been updated with resurfacing to Newdigate Road scheduled for 2015 /16. There is no mention of Rusper Road which was to be resurfaced during the same financial year.
