015d BROOK COTTAGE – Discussions had taken place with the newly appointed agent: (i) A development of more than one dwelling, possibly bungalows with some shared equity is being considered.

(ii)Quality and design must be maintained protecting the current landscape.(iii)The landowner must be proactive in taking enforcement proceedings. The PC will not make a contribution towards any enforcement action.

(iv)The strategy would be discussed with the PC and if agreed then with the DC.

015e GATWICK (i) <u>Airports Commission consultation</u> is likely to go out on 22nd October 2014 with a 3 month consultation period (to mid- January '15).(ii) <u>Gatwick Co-Ordination</u> <u>Group</u> letter to all PC's going out w/b 22.09.14 giving stats. on housing and jobs forecasts if 2nd runway developed and requesting confirmation of PC's support.(iii) <u>GACC</u> <u>Gatwick Protest meeting Saturday 22nd November, 2.00pm</u> Crawley Mosque.(iv) On <u>Tuesday 9th Dec. the PC will hold a Public Meeting at Capel Village Hall</u> regarding the Airports Commission Consultation on the Davies Commission plan for a second runway at Gatwick.(v) <u>Gatwick flight paths</u>: letter to be prepared listing facts re. the introduction of Route 4 design NPR without any form of public consultation and asking that the CAA revoke its introduction. The PC and residents to write to Chair of Civil Aviation Authority and Secretary of State for Transport expressing concern that the principal of democratic participation in the decision process has not been applied. Both documents to go in a Press Release.

015f EUROPA OIL - Once Surrey County Council has received full details of the relevant Environmental Impact Statement this application will become 'live'. There will then be a 28 day consultation period giving a deadline for responses by November 6th 2014. This means that at the earliest the application will go to the SCC Committee is 7th January 2015. (25th February if further information is required)

For ease of handling it was agreed that a bound copy of the application documents be purchased rather than working from a CD.

In order for residents to comment on the application the Parish Council will be holding its next Planning Committee Meeting on 6th October at the John Venus Hall, Coldharbour starting at 7.30pm.

016A BURIAL GROUND SHED

A secure replacement is being sought for the dilapidated wooden shed in the Burial Ground in order to store the mower used for the churchyard maintenance.

Friends of Capel Church had offered to contribute half the cost. It was decided that advice should be taken on whether a brick built construction with a concrete floor would be more cost effective / appropriate, the cost of a metal shed being £899.00. An application could be made to the SCC Local Committee for a contribution towards the cost.

016B4 Conclusion of External Audit September 2014

 As CPC income for 2014 – 2015 was over £200,000 the Council was required to complete an Intermediate Audit in addition to the standard submission of an Annual Return.
 The standard fee for income/ expenditure of £200,001 to £300,000 is £600.00 + VAT which will take us over our budget allocation of £1,000.00 for 2014/2015

2. CPC Annual Return has been 'qualified' because:

(i)BDO states that 'the Council have not carried out a risk assessment as part of its review of the effectiveness of internal control during the year ended 31st March 2014. A risk assessment was undertaken and reported to the Council after the year end. This risk assessment has been reviewed and is deemed to be adequate'

<u>The risk assessment was carried out on March 12th 2014 (within the 2013 /14 financial year)</u> – this was after the Agenda for the PC meeting on March 17th had been sent out. For this reason it was not reported to the Council (and minuted)until the PC meeting on April 14th (within the 2014 /15 financial year)

This situation cannot recur as the Council now has an item 'Finance' on its monthly agenda rather than just 'Accounts'

(ii)The one Minor Issue raised was that a figure which had clearly been crossed out, BDO deemed to ignore that it had been erased and included it as a mistake.

Cost of Elections 2015

Although costs have not been confirmed the likely cost to the Parish if each of the three wards is contested with more than 4 candidates standing in both Capel and Beare Green and more than 1 in Coldharbour (a total electorate of 5,300) – the cost would be £6,500. This would need to be factored into the Council's 2015 /16 budget.

016D GRASS CUTTING CONTRACT 2015

1)To date Burleys had submitted a quote for a 5yr contract. A quote is awaited from Kings of Dorking.

2) Burleys current 5yr.grass cutting contract expires at 31.10.14 at £5,406.00 inclusive of the maintenance of shrubs and grass round BG hall. Burleys are quoting a 5yr contract starting 1st April 2015 at £5,248.00 inclusive of the BG Hall items rising to £5,792.00 in 2019 (i.e rise of £545 over 5yrs)

016E PARISH AND HIGHWAYS MAINTENANCE

Parish Maintenance

(i)A quote is being drawn up for clearing the ditch in front of Greenside Cottages, The Street, in Capel. Removal of spoil must be taken into consideration in any quote.
(ii)Measures are being taken to trace the origins of the 'dry streams' in Capel that surge during wet weather e.g. to the back of Chantry Cottage, The Street, Capel
(iii)Highways to be approached with a view to the PC taking over mowing the verges in Markham Road. A quote to be obtained for the removal of overgrown shrubs, levelling and reseeding the verges. The SCC local Committee to be approached for funding <u>Highways Matters</u>

Newdigate Road and Rusper Road are listed for re surfacing during the current financial year. Newdigate Road in particular is in a very dangerous state. Cllr Clack (in attendance) will address the problem of the flooding ditch in Vicarage Lane at the next Highways Forum.
