# **CAPEL PARISH COUNCIL**

060. MINUTES OF MEETING held on Monday April 14th 2014 in the Committee Room, Capel Village Hall.

Messrs Birch and Jaques Capel Cricket Club presented a brief outline for a proposal to rebuild the Capel Sports Pavilion, enlarging the existing footprint and possibly incorporating the Youth Club building and land between the YC and the Village Hall. The current building has subsided on one side; the existing garage is integral which is not ideal from an H&S point of view and the size of the Club has grown to 2 adult teams in the 4 divisions, 5 junior teams, 1 kindergarten and 1 girls' team.

Expansion would involve redevelopment of changing rooms, showers and boiler room plus including additional floor space. Location of a detached garage would need to be decided. Various options have been drawn up including starting from scratch. If whole area were to be developed it would be a major project.

<u>Finance</u>: £50K grant from London Marathon Trust with possibility of doubling and could extend the grant 'take up' time. (see item 066A below)

**063. ALSO IN ATTENDANCE:** Cllr Homewood, Cllr Watson. Members of the public: Mary Huggins, Stephanie Jennings-Christensen, Max Rosenberg and Lindsey Simpson. Messrs Jaques and Birch, Insp. Rundle, PCSO's Booker and Sucha were in attendance for part of the meeting.

**DECLARATION OF INTEREST:** Mr McLachlan in relation to Europa Oil

**064. THE MINUTES:** Minutes of the meeting on March17<sup>th</sup> 2014 were signed as a correct record.

**065. MATTERS ARISING: Min. Ref.056C Coldharbour** /17.3.14: Steve Mitchell states that the route does not meet the Council's criteria / policy for a TRO as the condition of the surface is suitable for public use and there is no evidence to indicate that there is a specific and significant public safety issue which could be addressed/improved by a TRO to restrict vehicles.

**PUBLIC QUESTIONS:** Max Rosenberg, supported by Lindsey Simpson reported a significant increase in antisocial traffic, mountain bikes, 4 x 4's, motor bikes, vehicles with no number plates and uninsured vehicles using the BOAT. The Trail Riders Fellowship has been allowed in by SCC. The entrance into Wolvens Lane has been increased in size onto the bridleway. There is a big anti- social presence with walkers, horse riders, bikers and children sharing the same bridleway at any one time. There have been several near misses, property has been damaged, cyclists come down the hill and are unable to stop. A barrier to stop traffic /protect properties would be helpful.

**065a(i) POLICE MATTERS:** Recorded crime figures 17.03.14 to 14.04.14 showed 12 notifiable crimes of which 7 were in Capel, 4 in Beare Green and 1 in Coldharbour.

Of the 7 Capel offences: 1 x criminal damage to a motor vehicle, 1 x youth causing ASB in village, 1 x drug related, 1 x public order offence – dispute over collection of rubbish, 2 x other crimes, 1 x neighbourhood dispute.

Of the 4 Beare Green offences: 1 x theft of a pedal cycle and fridge, 1 x Burglary dwelling – jewellery stolen in Anstiebury Close, 2 x theft – handbag stolen on train and subsequently vehicle stolen which was later recovered after police pursuit.

The Coldharbour offence was a 5' x 3' hole dug on NT land similar ideal for badger bating.

**065a(ii)** Cllr Michelle Watson agreed to organise Neighbourhood Watch in Anstiebury Close

**065a(iii)** Insp. Rundle reported that he was in touch with the landowner at Brook Cottage and that significant environmental damage had taken place on the site. The only way the occupation of Brook Cottage land could be cleared would be for the landowner to get an Eviction Order through the civil courts. The landowner would then employ bailiffs to carry out an eviction. The bailiffs would then inform the police who would inform MVDC who would be obliged to find housing for the squatters.

**Response:** <u>Front elevation</u>: design is appropriate, would not have any adverse

impact. Rear elevation: Dormer window generally addresses Councillor's concerns but resident at no.4 (in attendance at the meeting) stated that dormer window directly overlooks entire garden of No.4. Side door is alien / unnecessary – intrusive because faces side of No 2. Shared septic tank with no capacity for additional drainage. In event that PP granted this property would need its own independent water and drainage with no cost falling to nos 1, 2 & 4. Fenestration style different from that currently and is out of keeping. Should not have approval for an increase to 4 beds. An increase to 4 beds would reduce its affordability in a location where there is already a

limted stock of affordable housing.

# 065e EUROPA OIL:

1) Appeal hearing is likely to be 24th April, confirmation nearer the date.

2)The PC had disputed the description of the site listed as Bury Hill Wood Quarry, Coldharbour Lane, Capel regarding a notice from Barton Willmore for Europa Oil and Gas publicising a forthcoming planning application for 'a proposed underground drilling corridor of an exploratory hydrocarbon borehole'. The document has now been amended to 'land at Bury Hill Wood, off Coldharbour Lane, Holmwood, Surrey and an underground corridor from under the land at Bury Hill Wood to land under Coldharbour Village. The proposed planning application is to be submitted on 24<sup>th</sup> April. BW has agreed to send copies of the planning document to the Clerk.

# 066A REDEVELOPMENT OF CAPEL SPORTS PAVILION

- (i)Initial discussions had taken place with YC representatives re the use / redevelopment of the YC building (which is a community asset) but Cllr Clack would need to be consulted re the future of the YC. In the interim the YC is having a last push for recruitment during May. A steering group to be set up for the project (Mrs Schryver is CPC rep. on the Sports Pavilion Committee).
- (ii) The Steering Group to report monthly to the PC on progress.

# **066B FINANCE**

- 1)The annual Risk Assessment had been carried out on Wednesday 12<sup>th</sup> March 2014 by the Chairman of the Finance Committee Cllr K Salter in the presence of The Clerk and the document had been duly signed.
- 1a) Cllr Salter considered the Council to be compliant with its procedures for Risk Assessment. The Risk Assessment report was recommended to the Council and adopted.
- 2) An Internal Audit had been carried out on Friday 11<sup>th</sup> April as yet the audit report had not been submitted to the Council.
- 3) BDO had confirmed Tuesday 17<sup>th</sup> June 2014 as the Council's External Audit date.

# 066C GATWICK AIRPORT 2<sup>ND</sup> RUNWAY CONSULTATION April 4<sup>th</sup> – May 16<sup>th</sup>

- 1) It was agreed that a £500 donation be sent to GACC towards fighting the 2<sup>nd</sup> runway proposals
- 2) Leaflets using similar copy to those recently distributed by GACC to be drawn up by Cllrs McLachlan and Watson for distribution to all households in the Parish prior to the exhibition at Dorking Halls on May 1<sup>st</sup>
- 3) Quotes for printing to be obtained from The Image Co. and Hurtwood
- 4) Cllrs Garber and McLachlan to attend the DA offices in Redhill to put forward the CPC response.
- 5) There are now 4 options listed on the response form, GAL having relented to have the 4<sup>th</sup> as 'None of these options'
- 6) CPC response to be based on the document submitted 10/2013 'Representations by CPC in Relation to Expansion of Gatwick and Heathrow Airports' including reference to the proposed development in the NE Sector of Crawley. Draft to be ready for approval at the meeting of the Planning Committee on 12<sup>th</sup> May.

#### **066D HIGHWAYS MATTERS**

- 1) Prior notification had been received from Highways re the proposed closure of the gap in the central reservation of the A24 immediately opposite Henfold Lane. This is due to police concerns regarding safety issues
- 2) Flooding issues in Vicarage Lane and Laundry Way (leading into Nunn's Field) in Capel and in Willow Close, Beare Green have been reported to Graeme Kane MVDC with a view to seeking advice on how to prevent any future recurrence.

# **066E WARD MATTERS**

**Beare Green** (i) Project OverHall update a)— the new lease is currently with the BGCA solicitor. There have been two dilapidations issues. An invoice for £9,600 for architects fees on the Gallery Wing had been received from Project OverHall. This would be held over for payment until a copy of the signed lease has been received. (ii) Verges in Old

<u>Horsham Road</u> – A site meeting with Highways had taken place. Use of Highways' funds is being prioritised and placing wooden posts to stop parking on the verge is not top priority. The matter is to be raised with Cllr Clack.

<u>Capel:</u> (i) Capel Playground – The revised proposals had been approved by London Marathon Trust and the start date is now 12<sup>th</sup> May. The cost to CPC will be £7,823.00 and the VAT will be recoverable.

<u>Coldharbour</u>:— Coldharbour Common Road by way: *in recess*: Cllr Watson stressed that she is lobbying SCC for a TRO but that this should be done through the Local Committee (date of June meeting 11<sup>th</sup> or 18th as yet unconfirmed) Steve Mitchell should be asked to reconsider his decision, but real evidence of what is taking place is required because SCC and DEFRA have certain criteria and policies for TRO's to be issued. The 4x4 users are a strong and experienced lobbying force. It is quite legal for traffic to travel at 60mph on CCRd although in practice it can be very dangerous. The village must be united (there must be consensus) in its view re. a TRO. Highways would be undertaking repairs in CCRd during the following week.

New evidence should be collected from residents (Cllr McLachlan to action)

### **066F PARISH MAINTENANCE**

<u>Holmwood Corner:</u> Following discussions with the NT it has been established that the row of 10 Poplars on the boundary of the allotments are the responsibility of CPC and that they should be felled at fence level. Mattree has quoted £2,200 ex VAT and Clay Griffin £1,375 for felling and removing arisings. Councillors agreed that Clay Griffin be asked to undertake the job.
