096B RESPONSE TO SURREY CYCLING STRATEGY CONSULTATION

The draft response drawn up by Cllr McLachlan had been circulated. Councillors were pleased to note that funding had been secured for the first phase of a dedicated mountain-bike trail on Leith Hill and that local cycle shops were playing an important part contributing to working groups, designing new trails and helping significantly to decrease off-piste mountain biking e.g. the Hurtwood Estate and Surrey Hills AONB. Various minor additions were to be added and the document to be forwarded to SCC by 01.11.13. Cllr. McLachlan would be attending the Surrey Cycling debate hosted by the BBC on 22.10.13 and was thanked for producing an excellent report.
