035b CAPEL YOUTH CLUB BUSINESS PLAN

Nick Ward presented the Plan, copies having been circulated (on file). Withdrawal of support from Surrey Youth Development Scheme had meant an annual reduction of £2,500 in funding and consequent reduction in staff who previously ran the Monday and Wednesday sessions. Matched funding has been halved by the PC to a limit of £250 + part of transport costs. The Centre made a loss of £957 last year inclusive of funding external works and internal painting.

Three major fund raising events had been held raising a total of £2,895. Subscriptions remain at £1 per session for the 678 Club and every effort is being made to explore available avenues for grant aid.

Challenges for the future are to:- embed the DofE initiative; extend services to other members of the older age group; ensure that the 678 Club and the Jesus Fun Club continue to thrive; become financially self-supporting, building on the progress made during 2011. Further figures to be submitted to the PC for projected income and expenditure over the next 5 yrs

035d UPDATE ON EUROPA OIL PLATFORM APPEAL

<u>Under Appeal Section 78: Site at Bury Hill Wood</u>, off Coldharbour Lane, Holmwood, Surrey.MO/09/0110

- (i)The Planning Inspectorate is in receipt of the CPC response and the request to speak acknowledged with the suggestion that Mr Garber attend the start of the inquiry and inform the Inspector that he wishes to speak. The Inquiry is scheduled to start on 10th July and last 8 to 10 days.
- (ii) SCC Solicitor has acknowledged receipt of CPC's letter requesting the Inquiry be held at Pippbrook, however the venue is yet to be determined.
- (iii) MVDC has confirmed that it will be responding in the same manner as for the original planning application

LHAG 'statement of case' has no reference to 'the trees'

CPC has not asked for Rule 6 status.

036A LOCALISM

- a) Copies of Neil McDonald's Neighbourhood Planning 2011had been distributed to all Councillors for use as a reference.
- b) Mrs Schryver, Mrs Pearson and the Clerk to attend the SCAPTC Localism Conference in East Grinstead on 20th April. Mr McLachlan also expressed an interest.

Further clarification was needed re statutory consultee status.

<u>Localism costs</u> – The District will pay for referendums but Jack Straw to be asked for clear confirmation as to which costs would be attributable to the District.

036B FINANCE

- (i) Minutes of Finance meeting 01.02.12 had been distributed and were adopted.
- (II) Requests for grants:

- a)It was agreed to take out Corporate Membership with <u>Dorking and District Preservation Society</u> for a £10.00 annual subscription.
- b) Capel Youth Club The PC had budgeted £250 for 2011/12 further information on projected income and expenditure for the Club was awaited.
- c) Purchase of a single reconditioned Kazabaloo Eco Friendly Toilet costing £995 is being sought by the Temple Lane Allotment holders. Councillors thought this too expensive and that other options should be considered.
- d) LHAG is appealing for £50,000 to cover expected costs of its appeal in July. The Hearing is expected to last 10 days with an anticipated cost of £1,500 per day for Barrister's fees. Expert Witnesses will be charging. In the case of the incinerator, the Capel Action Group was a committee of the Parish Council, all witnesses acted for 'no fee' and the majority of funding was from private donation. The incinerator was a parish wide issue involving areas covered by the A24, A29 and A25.

It was noted that the PC would be incurring approx. £2,000 in costs of its own at the appeal.

A statement of projected costs and likely donations was requested for presentation at the March meeting.

036C QUEENS DIAMOND JUBILEE CELEBRATIONS

1) Jubilee Elm trees- costings

5 disease free Elm trees 7 to 9ft in 10litre pots @ £75 per tree = £375.00 Delivery of 5 trees = £75.00 Planting by Wesley Attridge = £180.00 = £180.00 = £630.00

Costs were agreed but due to the predicted draught conditions it was decided to delay ordering until October 2012.

036D FINAL RECOMMENDATIONS ON NEW ELECTORAL ARRANGEMENTS FOR SURREY COUNTY COUNCIL

In Mole Valley District the strong boundaries to north, east and west of Leatherhead and the lack of electoral equality inherent in alternative proposals means that the Draft recommendations are confirmed as final for Givons Grove and Tyrell's Wood area which would be part of the Dorking Hills Division.

The proposed changes will come into force at the next elections for SCC in 2013.

036E HIGHWAYS MATTERS

1. Parking outside The Old Forge Surgery, Capel

Cllr Helyn Clack to be approached about further road markings

2. Flooding in Temple Lane

Measures are being taken to clear the field ditch to free flood water in Temple Lane.

3. <u>Cable laying in The Street, Capel.</u> A second gang to be moved to the village centre to try and speed up work. Project to be completed by the end of March.

036F WARD MATTERS

Beare Green: (i) Project OverHall - the refurbishment / rebuild of the Beare Green Village Hall. The type of building is currently being considered. John Thom has joined the team as a consultant. Grant money is being held over until 2014.

Capel:

- 1)Travellers have finally been removed from Knoll Farm Road and access to both dwellings is now blocked by concrete.
- 2)There is concern that rubbish left in the field adjoining No 9 Broadwood Cottages, being visible from both Temple Lane and Vicarage Lane, will lead to further fly tipping and / or encourage more travellers. Steps are being taken to get the rubbish removed.

Coldharbour:

Coldharbour Lane.

- 1. Councillors considered that carrying out the FC's proposed tree felling programme would be altering the character of the Lane and that felling the trees but leaving the roots would undermine the integrity of the banks. It would be inappropriate to put down mesh because of the visual impact, although low growing plants could be planted to grow through biodegradable mesh. The Clerk to write to Highways (via Hazel Watson) requesting that 1) A Temporary Width Restriction be imposed on Coldharbour Lane and that b) a Temporary Order Preventing the felling of any trees in Coldharbour Lane be imposed.
- 2. <u>High Speed Broadband</u> –Bt are offering 2 free lines to public places in the Parish + £300 to spend on a party. Also a publicity bus for use at the C/H Fete and the Flower Show in August.

036G PARISH MAINTENANCE

Bridlepath 214 – Misbrooks Green

The state of the bridle path has deteriorated further since the Council's letter to Bill Kear in January. A site meeting has now been agreed for Friday 24th Feb.
