025d UPDATE ON GODWINS NURSERY SITE, BEARE GREEN

Crest, the appointed developer for the Godwins site, is preparing a new Plan which it intends to consult fully with the whole Beare Green community on; this to take place in February or early March.

Crest supports the development of the whole site, Mole Valley support the principal of development but believe it should be restricted to the former nursery and Wren Cottage.

026A QUEENS DIAMOND JUBILEE 2012

1) Elm Trees

King & Co, the Essex nursery that developed disease resistant Elm trees, are quoting the cost of a 7-9 ft tree in a 10 litre pot at £75.00 each including VAT with a delivery charge of £25.00 per tree inc VAT.

It was agreed that 7 to 9ft would be an appropriate height but the Clerk to query the delivery charge of £25.00 per tree.

Misbrooks residents have agreed to 3 trees which would be planted 30ft apart along the northern edge of Misbrooks Green.

There would be the additional cost of deer protection.

Tree numbers: 3 for Capel, 1for Beare Green (awaiting response from D Cox), Mr McLachlan to approach the NT re planting at Coldharbour. Mr Dale would like to order 2.

2) <u>Community Picnic and entertainment</u>. The Horticultural Society Committee is proposing to hold a Community Picnic on Capel Rec on Bank Holiday Monday 4th June. The various village organisations are to be contacted to organise entertainment, games and competitions for all.

026B HIGHWAYS MATTERS

1. Parking outside The Old Forge Surgery, Capel

Highways have investigated the possibility of improving the signage outside The Old Forge Surgery to indicate to through traffic that the road narrows. Cllr Clack to be contacted as Highways say nothing can be done.

2. Flooding in Temple Lane

Highways have complained about the flooding by both road bridges. Water is backing up in the field ditches. The PC's contractor will clear under both bridges once the field ditches are freed.

3. Flooding by Weald School entrance

Concrete was removed from a blocked drain (left after the Weald School entrance widening). Further work to be undertaken to clear ditch to the front of the Dukes Head.

4. Flooding in Rusper Road – on the PC northern verge. Investigations are being made re a possible water leak.

026C WARD MATTERS

Beare Green: (i) Project OverHall - the refurbishment / rebuild of the Beare Green Village Hall: the Beare Green Community Association had produced an excellent brochure explaining the project, describing Beare Green as a community in need, outlining the existing community facilities and the options under consideration for providing a sustainable hall that will meet the immediate needs of the community and the expectations of future generations. The decision had been taken not to apply for the Village SOS money this year as the project is not sufficiently well advanced. Up to £300,000 could have been accessed for the project in 2011 with more in 2014 / 2015. The website is not in place and there is not sufficient definition in the plans, also there is a lack of understanding of 'matched funding' (ii) Parking in Old Horsham Road: work should be carried out in the next 2 months

Capel:

After successful removal from Temple Wood there has been an incursion of travellers in Knoll Farm Road, Capel in the garden at Sunnyridge. SCC own the property and the one next door, as part of their compulsory purchases for the A24 road improvement. SCC officers have visited the site with the Police and are applying for a vacant possession order through the magistrates' court. Once evicted SCC plan to block all access to the site with concrete and fencina.

Coldharbour:

A meeting with the Forestry Commission is due to take place to discuss the Arborial report on the trees in Coldharbour Lane.
