Response: While the Parish Council has no objection to the general principle of a

development aimed at the sustainable agenda it has strong reservations

regarding the size, scale and mass of the proposed structure.

It lies adjacent to Temple Lane which has an intrinsic rural charm and character. Although the proposal would be set behind a hedge it would be

visually instrusive and as such, harm the visual integrity of the Lane.

In the opinion of the Parish Council the applicant should reconsider the proposal with a view to reducing its length by approximately 50% with a height to not more than 4 metres to the ridge. The applicant is invited to

submit a revised scheme to the Parish Council for its consideration.

8. Neighbourhood Plan

(i)The Chairman confirmed the first meeting of the Steering Group will take place on 10th June, 2015.

(ii)In relation to the promotion of the Plan to the community, the 'signage' concept adopted by Slinfold Parish Council was considered to be a good example of making the community aware of the Neighbourhood Plan.

(iii) It was noted residents have now received a notification letter from Mole Valley District Council.

9. Gatwick update

In response to GAL's invitation to meet Sir Paul Beresford, Mr Kirwan-Taylor and Cllr Clack a meeting was to be offered with Mr Garber, Cllr Osborne-Patterson and Mrs Schryver in Capel on 26.06.15 or 29.06.15 in Capel.

The Chairman went into recess to enable District Councillor, Mrs. Osborne-Patterson, to participate in the discussion.

He referred to the comments submitted to the Gatwick Co-ordination Group and to correspondence with GAL regarding the failure to communicate an invitation to the Parish Council to consider PR-NAL proposals.

The Clerk has not received a letter from GAL indicating their willingness to meet. It was agreed to secure the meeting in Capel. The Parish Council representatives will be the Chairman, PC Chairman, Mrs.Schryver and Mole Valley Councillor Mrs. Osborne-Patterson (who had attended the earlier meeting with GAL).

10. Europa Oil & Gas

Mark O'Hare, SCC Acting Principal Planning Officer had confirmed that (i) SCC Planning Committee would consider the Europa Oil and Gas application SCC 2014/082 Bury Hill Wood on 15.07.2015. (ii) Elected representatives of Parish and District Councils, Residents Associations and representatives of bodies and organisations are not eligible to speak. Members of the public and residents can speak but need to have submitted an individual representation on the application in question 14 days before the committee date.

If individuals wish to address the SCC Committee in July they must object and request to appear.

The next meeting of the Planning Committee will be on Monday July 6th 2015 at 7.30pm in the Committee Room, Capel Village Hall. The Planning Committee will report to the meeting of the full Council on Monday 15th June 2015.
