**7. Appeal**: (i) **APP/B/3600/A/11/2166561RV** Europa Oil: Responded in detail on 5<sup>th</sup> December 2014 with agreement from the full Council. In relation to the Aquifer the submission had stated 'the Parish Council accept that the exploration proposals are unlikely to have an adverse impact upon the aquifer'

In response to a letter received from LHAG dated 24<sup>th</sup> Feb 2015 The Parish Council consider its response to the extant application dated 12<sup>th</sup> January, 2015 is both appropriate and reflects an accurate representation of the Council's position.

With reference to the acquifer; having had regard to the E.I.A. CPC position is clear. We state that the proposals are 'unlikely' to have an adverse effect. We have also had regard to the letter from S/ES Water, the response by the applicants and the position of the E.A.

## 8. Creation of Bridle Way 269 and Extinguishment of FP 185

The Parish Council supports and recommends the creation of Bridleway BW 269. The Council also consider that Public Bridleway BW 186 from Clockhouse to Rusper Road (Route D-E) should be stopped up on a permanent basis.

The route along Rusper Road from Point E to Point F is dangerous for pedestrian and equestrian users.

In relation to FP 185 this footpath route should be retained. A distinct footpath and bridleway is desirable for the benefit of the respective type of user.

## 9. Brook Cottage:

The Parish Council met the consultants to consider their draft scheme. A scheme will be prepared for further consultation with the Parish Council and the Community.

An application is anticipated to be made in May/June 2015.
