## 9. Neighbourhood Plan

The Local Plan had now been put back 3yrs. With the Parish's own Neighbourhood Development Order and Neighbourhood Plan in place (approved by MVDC) it would take away from MV the ability to decide where housing in Capel Parish should go. Public consultation would be needed as well as protection of village assets and community infrastructure.

Village and Landscape appraisals have already been submitted. Ockley already has its own Neighbourhood Plan with the advantage that it was excluded from the Housing and Traveller sites consultation.
