## 6. CONSULTATION ON MVDC H&TSP additional sites:

The draft representation of the PC had been detailed on the PC Web Site following the meeting on 2<sup>nd</sup> June. The Chairman indicated that 11 letters had been received all of which addressed matters already detailed in the draft submission and that no changes were required apart from the alteration to a paragraph ref to the NPPF.

No further comments were made by members of the public attending the meeting.

It was also agreed that in due course when the MVDC Consultation on sites is published a Planning Committee Meeting dedicated to the matter will take place when all proposals will be considered.

The Parish Council APPROVED the draft representation for submission to MVDC as detailed:

#### (i) BG09 Land South of Beare Green

The Parish Council **OBJECTS** to the proposed site for housing its formal response to the Mole Valley Consultation will be considered at the meeting of the Planning Committee on 7<sup>th</sup> July 2014. The areas of objection referred to by the Parish Council and the public included:- Green Belt, access, flooding, impact upon community, facilities, services, sustainability, landscape and AONB.

An additional reference will be made to CIL and the obligations in relation to agreements under section 123 of the Highways Act 1980

# (ii) CP11: Land at Hurst, Vicarage Lane, Capel

The Parish Council **SUPPORTS** the proposed site in principal but does not agree with the strategy outlined in the Mole Valley District Council Consultation. The site is in an important location providing a transition in landscape and character terms from The Street into Vicarage Lane, providing an important 'rural' framework which must prevail with the mature trees being retained.

Its proximity to the Conservation Area, Green Belt constraints and its treescape requires a sensitive high quality design which could best be achieved by a 'limited' flatted redevelopment (max 4) planned around the existing development footprint.
