## 7. Project OverHall – David Lloyd and Pam Marsh gave an update.

**Lease** – No further information is available. Richard Burrows and Yvonne Rees MVDC had not responded regarding the extension of the lease. Need to discuss Terms and Conditions. There is no draft Heads of Terms. Delaying will increase costs and constrict time scales. No one at MVDC appears to understand the process.

**Formal application for funding** – Satisfactory answers had been given to the 7 points the PC had asked for clarification on (see attached sheet) and it was now felt that the committee had provided the necessary data showing the project to be financially viable and sustainable.

Further discussions would be necessary on securing a satisfactory resolution to the extension of the lease before the grant could be enacted.

## 8. Land at Godwins (update)

- (i) Completion date is now set for 8th November and documents have been signed.
- (ii) Post completion a letter to be sent reminding Crest that each additional dwelling will trigger an additional £10.000
- (iii) All monies after deduction of costs, to be paid into the PC's NS&I a/c

## 9. Weald School Development (update)

Revd.Steadman-Allen had written, as a community leader, a very constructive article regarding the option of an entire rebuild as being a valuable community asset but with the disadvantage that the development would result in the loss of Green Belt land.

No further details available on 'the next steps' available.

#### 10. Surrey Cycling Strategy Consultation

- (i) A summary of the Cycling Strategy debate 23.10.13 had revealed that the SCC Cabinet had agreed in late 2011, prior to the Olympics, that the Prudential Race will be run for a period of 5yrs, this decision being taken without any public consultation whatsoever. A request was made that the PC should discuss at its meeting on 18.11.13 a proposal to send a formal letter to SCC indicting its intention to take out an injunction against SCC regarding this matter; and to ask other Mole Valley PC's for their support.
- (ii) Representatives from the Parishes are invited to a meeting at Dorking Halls on <u>Wednesday 20<sup>th</sup> November 6.30 till 8.30pm</u> to hear about preparations being made for RideLondon 2014
