7. UPDATE ON EUROPA OIL

(i) David Boswell had reported that he was continuing his review of the evidence submitted by Europa Oil & Gas from which it appeared that there is no separate highway or transport evidence. He had concluded that both the appellant and SCC had failed to properly consider the impact of the scheme on Coldharbour Lane.

- (ii) David is agreeable to appearing at the Inquiry on the PC's behalf and suggests the 17th July as the optimum date to allow him an opportunity to prepare and submit a rebuttal before he appears should the Appellant submit highways evidence on the opening day of the Inquiry.
- (iii) The Inquiry starts on Tuesday 10th July at 1.30pm in the Martineau Hall, Dorking Halls and between 9.30 and 5.30pm on 11th 13th July; Tuesday 17th July to Friday 20th July; Closing submissions are on Tuesday 24th July followed by a site visit on Wednesday 25th July.
